

CHICAGO WHITE SOX ELITE WINTER CAMP

The 2011 White Sox Elite Winter Camp is a two-day camp with each day featuring two, forty-five minute skill specific instruction sessions consisting of baserunning/ bunting, hitting, pitching/ throwing mechanics and infield/outfield defensive training. Each camper will spend a session with some of the top coaches in the White Sox organization including: Devon White, current White Sox Minor League Baserunning/Bunting Coordinator and former World Series Champion, Gold Glove winner and MLB All-Star; Jeff Manto, current White Sox Hitting Coach; Kevin Hickey, current White Sox Special Assistant to Don Cooper; Larry Owens, current White Sox Minor League Pitching Coach as well as Elite Academy instructors Justin Stone, Sam Zagorac and Michael Huff, former White Sox outfielder and current VP of Sports at the Bulls/Sox Academy.

DEVON WHITE - Devon White is currently the Chicago White Sox Minor League Baserunning/Bunting Coordinator. Devon played 17 years in the Major Leagues and was played on 3 World Series Championship teams. In addition, Devon was a 3-time All-Star and won 7 Gold Gloves. He is considered one of the greatest lead-off hitters of all-time due to his combination of power and speed, finishing his career with over 200 homeruns and 348 stolen bases, a success rate of 78%. During this camp, Devon will cover proper bunting mechanics along with baserunning fundamentals which will make every camper a much better baseball player.

JEFF MANTO - Jeff Manto is the current White Sox Hitting Coach and former White Sox Minor League Hitting Coordinator. Jeff played in parts of 9 seasons in the Major Leagues and tied a major league record with hitting four consecutive homeruns in four consecutive at-bats. He has recently overseen the development of White Sox players like Dayan Viciedo, Tyler Flowers and Brett Morel to name a few. Prior to his current position with the White Sox, Jeff was the hitting coach for the Pittsburgh Pirates (2006-2007) and had the opportunity to work with today's homerun king, Jose Bautista. Jeff will cover the same hitting fundamentals that he has implemented within the White Sox organization, including the mental side and the importance of having quality at-bats.

KEVIN HICKEY - Kevin Hickey is currently part of Robin Ventura's big league staff, serving as a special assistant to the team while also assisting Don Cooper with the pitchers during the year. Kevin played in parts of 6 seasons in the Major Leagues and made his big league debut in a White Sox uniform. He was originally drafted by the White Sox and is a Chicago native. Kevin along with Larry Owens, will cover different aspects of pitching, including the mental aspect and the importance of throwing strike one.

LARRY OWENS - Larry Owens is currently a minor league pitching coach for the Chicago White Sox and spent this past summer as the organization's pitching coach at Class "A", Bristol. Prior to the White Sox, Larry was an established pitching coach at the college level, serving as pitching coach at the University of Memphis (2001-2004), Austin Peay (1999-2000) and the University of Louisville (1996-1997). Larry has served under Dave Anderson, current 3rd base coach of the Texas Rangers, and long time major league catcher Terry Kennedy. Larry is a great communicator and has an incredible understanding of the pitching mechanics. He was originally drafted by the Atlanta Braves.

MICHAEL HUFF - Michael Huff is currently the VP of Sports at the Bulls/Sox Academy. Michael played in parts of 8 seasons in the Major Leagues including parts of 3 seasons with the White Sox. During Michael's stay in Chicago, he played with White Sox new manager Robin Ventura, Frank Thomas and Carlton Fisk to mention a few. Michael was originally drafted by the Los Angeles Dodgers after attending Northwestern University.
